€0.10 per unit imported (ex vat) for all categories of tyres
Minimum fee of €45.00 ex vat (€54.45 vat inclusive) applies



WHOLESALEERS, RETAILERS, WASTE COLLECTORS

€54.45 (and €36.30 for each additional site) vat inclusive.



FARMERS

Transactions from WASTE COLLECTORS to FARMERS will be recorded, but there will be no fees applied to FARMERS by TRACS at any time.

RENEWAL FEES

PRODUCERS / IMPORTERS

The importers fee applies to members who import more then 200 tyres per year.

€0.10 per unit imported (ex vat) for all categories of tyres
Minimum fee of €20.00 ex vat (€24.20 vat inclusive) applies



WHOLESALEERS, RETAILERS, WASTE COLLECTORS

€24.20 (and €6.05 for each additional site) vat inclusive.
